## **DROP OFF PROCEDURES**

### **Pre & Post Camp Care:**

Morning Pre-Camp will be held in the Gym or Playschool Room A. The program may be divided into two groups based on grades and/or activities. The groups will alternate between the Gym and the classroom.

**Parents will be expected to sign their child in when dropping them off.** Post Camp will be held in the Senior Room. **Parents will be expected to sign their child in and out when picking them up and dropping them off.**

### **Full Day Camp:**

Participants enrolled in Full-Day Camp, should enter through the main entrance and proceed to the Gym. Campers will not be permitted in the building without parent supervision until 8:25 a.m.

**Parents will be expected to sign their child in with the child's group counselor.**

### **Summer School Drop Off:**

Campers who are registered for the Summer School option will be dropped off at the park district from the Wood Dale School District #7 bus. Campers arriving on the bus from Summer School will meet in the lobby where attendance will be taken by a counselor. **Campers will not be allowed to walk from Summer School to the Recreation Complex.** They will be expected to ride the bus both ways. **It is the parent's responsibility to make arrangements with District #7 for bus transportation.**

## **PICK UP PROCEDURES**

### **Sign Out:**

Campers must be signed out by a parent or authorized pick up at the conclusion of their camp day.

### **Authorized Pick-Ups:**

The registration form will ask for names of people who are authorized to pick your child up from camp.

**IMPORTANT:** Campers will only be released to the people listed on the Authorized Pick-Up List, unless you contact the Deputy Director or Camp Director to make other arrangements. All individuals authorized to pick-up your child will be required to show a picture ID.

### **Pick-up:**

Campers will gather in the Gym between 3:50 to 4:00 p.m. for pick up. Parents will be expected to wait in the lobby until attendance has been completed. Participants not registered in the Post Camp Care must be picked up by 4:00 p.m. to avoid late fees. At 4:00 p.m. any campers still remaining who are not registered for Post Camp Care will be brought to the Lobby. If you need to pick up your camper prior to the end of camp (4:00pm), you will need to consult the sign in the Lobby (by the elevator) to locate your child's group. **Parents will be expected to sign their child out with the child's group counselor.**

### **Post Camp Care Pick-up:**

Campers registered in Post Camp Care may be divided into two groups. Groups will alternate between the Gym and classroom activities. Campers must be picked up by 6:30 p.m. to avoid late fees.

### **Late Fees**

Pick-up times are strictly enforced. If your child *is not* registered in the Post Camp Care you must pick them up by 4:00 p.m. to avoid a late fee. If your child *is* registered in Post Camp Care you must pick them up by 6:30 p.m. to avoid a late fee. If you are unable to pick your child up on time, it is your responsibility to make other arrangements. Because we realize that work or traffic conditions are sometimes beyond your control, we will allow for two late pick-ups, up to 15 minutes. If you are more than 15 minutes late or you have already used your two free late pick up, late fees will be charged per day.

Late Fees: Late fees must be paid at the Front Desk before the camper registered for next session.

\$ 5 for 0 – 15 minutes late

\$10 for 16 – 30 minutes late

\$15 for over 30 minutes late

### **PAYMENT PROCEDURES**

Payments can be made at the front desk during office hours or placed in the payment drop-off box located to the right of the elevator. When using the payment box, please place the payment in an envelope clearly labeled with the child's name and what camp session and days you are registering for. The payment box is checked before the building closes at the end of the day.

**Payment is due at the time of registration. If you would like to sign up for AUTO-PAY you have to contact the Recreation Supervisor or Camp Director and they will hold your credit card information and run the payments the Friday before the next session begins at 12:30PM.**

**\*Registration and payment are due every Friday by 12:00pm for the following week of Daycamp.**

**\*Registration and payments made after this time will be subject to Recreation Supervisor or Camp Director approval.**

### **Attendance**

You are encouraged to call the Recreation Complex at (630) 595-9333, if your child will be absent for daycamp. As a courtesy, please be sure to contact earlier if your child will be absent on a field trip day. The office does not open until 8:30 a.m. but you may leave a message prior to opening. Staff will not be making regular phone calls home due to absences but will verify on field trip days. If a child is due to arrive at the Park District on the bus from Summer School and they do not arrive, a phone call will be made a.s.a.p.

## **Lunch**

Don't forget to send a lunch with your camper(s) each day. Vending (food/drinks) machines, refrigerators and microwaves are **NOT** available during lunch time. Food sharing is also not permitted due to allergies.

We understand that occasionally, a child will forget a lunch at home. The Park District will provide your child with a sandwich, snack, and drink. If this becomes an ongoing problem you will be contacted by a Camp Director to discuss the matter.



## **Medication**

If your child needs to take medication during camp hours, it will be stored in a safe, which is located in the camp rooms. Please fill out a "Permission to Dispense Medication" form at the end of the registration packet. Medication must be submitted in its original bottle. Parents are expected to provide a doctor's note for prescribed medications. Participants are not permitted to store any type of medication in their lunchbox, bags, or pockets. This includes cough drops, inhalers, epi-pens, over the counter medications, and prescription medications. If your child has a food allergy, your child's physician will be expected to complete a food allergy action plan. Forms are available upon request.

## **Health**

For the health and safety of all participants and staff, the following health regulation is required. Please notify us if your child has a communicable illness so that we may inform other parents (send out a note) to watch for symptoms.

Recreation Complex Staff has the authority to refuse any child that may show signs of any contagious illness. In such cases, the judgment of the staff is final and refusal to come pick up the child will result in dismissal from that camp session. If your child had a fever, they must be fever free for 24 hours in order to return back to camp. Staff also has the authority to request that you provide a note from your child's doctor stating that the child is able to safely return to the program.

## **Custody Situations**

Both parents will be allowed to pick up their child at any time unless you provide legal documentation such as court orders explaining your custody arrangement. Please bring your most current documents to the office and we will copy the sections pertaining to custody. Documents from past school years need to be re-submitted.

## **Parking**

Parking is not permitted in the bus/emergency lane. In this area, drivers must remain in the car in order to move their vehicle immediately if a bus or emergency personnel arrive. Cars left unattended in the bus/emergency lane may be ticketed or towed.

## **Parent Communication with Children**

Parent/adults are not allowed to speak to children other than their own regarding that child's behavior. If there is a problem between your child and another, please bring it to the attention of staff or have your child do so. Only Park District Staff is permitted to discipline or question a child in their care during camp hours.

If a parent must reach their child at camp due to an emergency, please call 630-595-9333 and ask for a Recreation Supervisor or Camp Director. They will locate your child and bring them to the phone. Please remember the staff's responsibility is supervising the children, so we ask that phone calls are kept to a minimum and only made in emergency situations.

## **Parent/Guardian Code of Conduct**

Parents/Guardians are expected to exhibit appropriate behavior at all times while participating in any day camp session, event, or activity with the Wood Dale Park District. It is recommended that parents discuss with their children that activities are planned for groups and while their child may wish not to participate in a specific activity, he/she is still expected to make an effort to be a part of the program. The following guidelines are designed to provide safe and enjoyable activities for all participants. Additional rules may be developed for particular programs and athletic programs as deemed necessary by staff.

Parents/Guardian shall:

- Show respect to all campers and Staff, and take directions from staff if necessary.
- Refrain from using abusive or foul language.
- Refrain from causing bodily harm to self, other participants or staff.
- Show respect to equipment, supplies, and facilities.
- Take direction from day camp staff and supervisors.

The Wood Dale Park District, it's counselors, supervisors, and administrative staff, reserves the right to suspend or deny participation in or viewing of any day camp session, event or facility to any person whose behavior materially interferes, or disrupts the quality of those offerings, the enjoyment of them by other participants, or the ability of staff to conduct or manage the activities or facility.

## **Disciplinary Action**

The Park District day camp STAFF will follow a progressive form of discipline, when deemed appropriate. This will be discussed on the first day of camp\*. We do have the right to remove your child from a certain camp session depending on the continued behavior displayed.

## **CAMPER RESPONSIBILITIES:**

### **Code of Conduct**

Campers are expected to exhibit appropriate behavior at all times.

Participants shall:

1. Show respect to fellow campers and all staff.
2. Take directions from staff.
3. Refrain from using abusive or foul language.
4. Refrain from causing bodily harm to self, other campers, or staff.
5. Show respect to equipment, supplies, and facilities.

Participants who do not conform to these rules risk extended time outs, removal from class into the office, suspension or dismissal from the program.

### **Discipline**

The purpose of discipline is to help a child develop self-control and learn to assume responsibility for his/her own actions. It is also necessary for the safety of all campers and staff. Campers are encouraged to follow the six pillars of the Character Counts program. We use corrective statements and "time-outs" to redirect negative behavior. Recurring or major problems will be documented through an incident report and discussed with the parent/guardian. The Recreation Supervisor and the Camp Director have the right to dismiss any camper that has continued to misbehave during a camp session and there will no refund given upon dismissal.

## ADDITIONAL INFORMATION

### Items from Home

Participants should leave all toys, electronic games, cell phones, MP3 players and other items at home. Unauthorized items will be stored in the camp office and must be signed out by a parent.

*The Wood Dale Park District is not responsible for any lost or stolen items.*

### Appropriate Attire

Make sure your child wears gym shoes and comfortable clothes to camp each day. Clothing with alcohol, cigarette advertisements and/or explicit or profane messages will not be allowed at camp. Parents will be contacted and expected to pick up their child or bring a change of clothing. Additionally, parents may be contacted, if their child is wearing revealing clothing. Campers who are not wearing gym shoes will not be allowed to participate in activities that include running.

Campers should bring a towel, swimsuit, and flip flops or water shoes to change into for swimming.

### Extra Materials

Parents are encouraged to apply sunscreen and bug repellent to campers before arriving at camp. Camp Counselors are only allowed to apply sunscreen if it is spray so please send spray on sunscreen for the younger aged campers. Campers will need to apply extra sunscreen and bug repellent every so often to eliminate sunburn and stings if possible. Parents may complete a sunscreen/bug repellent permission slip which allows the Wood Dale Park District staff to provide sunscreen or bug repellent for your child to apply. **Campers are also encouraged to bring bottled water to camp every day. They will be allowed to bring the water on field trips, on walking trips and to activities. Water bottles must be filled with regular water only. No flavored waters, juices, etc. will be permitted. Please be sure to label your child's water bottle.**



### Camp Swim Lessons

Parents now have the option to register for swim lessons by week! Swim classes will be on Tuesdays & Thursdays. The cost per week of swim lesson is \$10.00 Please refer to the table below. Swim lessons will be held from 9:15-10:00 a.m. Children registered for camp swim lessons will be bused to and from lessons, which are held at The Beach. Please make sure your child has a swim suit, towel and sunscreen if they will be participating in lessons. Swim lessons are not included in the fee. Parents will be expected to register separately for swim lessons, in addition to a full day of camp. Questions regarding swim lesson should be directed to the Manager of Recreation Facilities.

### Swim information

Each child will be tested by a The Beach Pool Manager and Camp Director before they will be allowed to enter the pool. They will be given a wrist band which will let the lifeguards and camp staffs know their swim level.



The children will then only be allowed in certain areas of the pool depending on their swim level. The camp staff is stationed inside and outside of the pool and rotates every 15 minutes to insure the safety of the children.



### **Field Trips**

Field trips are included with each week of camp. A variety of trips will be planned over the course of the summer, and may include water parks, amusement parks, or minor league games. Trips will be scheduled on Wednesdays. All groups will be attending the field trip together with their counselor's groups. Campers will be expected to wear a provided camp shirt on field trip days. Parents may elect to not send their child on a scheduled field trip; however no refunds will be granted for missed trips due to deposits and numbers already being submitted.



### **Field Trip Shirts**

All campers will be provided with a camp T-shirt at the beginning of the first week they are registered for. Campers are expected to wear their camp T-shirt on Wednesdays for field trip outings. Replacement shirts may be purchased for \$5 while shirts are available. Please see the Recreation Supervisor or the Camp Director if you need to purchase an additional shirt.

### **Snack**

The park district will provide an afternoon snack on a daily basis. Campers will be allowed to bring a snack to eat in the morning. Participants are not allowed to use the drink or food vending machines. Food sharing is not permitted due to allergies.

### **Summer School Transportation**

Bus transportation will be provided for children who will be participating in Summer School through District #7, and also attending Summer Camp. Campers will not be allowed to walk from Summer School to the Recreation Complex. They will be expected to ride the bus. It is the parent's responsibility to make arrangements with District #7 for bus transportation. Please note that we can only have summer school kids' sign up for M,T,H, and F due to our field trips on Wednesdays.

### **Abuse and Neglect**

In accordance with the procedures set forth in the Abused and Neglected Child Reporting Act, the Wood Dale Park District personnel, having reasonable cause to believe that a child known to them in their professional capacity may be an abused or neglected child, shall immediately report the matter to their supervisor. The proper authorities will then be notified.

### Important Information

- *Swim Program* – The Wood Dale Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of campers in high regard. The Wood Dale Park District continually strives to reduce such risks and insists that all campers follow safety rules and instructions that are designed to protect campers' safety. However, campers, parents/guardians, and parents/guardians of minors registering for lessons must recognize that there is an inherent risk of injury when choosing to participate in the recreational activities. You are solely responsible for determining if you or your minor child/ward is physically fit and/or adequately skilled for the swim lesson contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.
- *Warning of Risk* – Swimming is a sport which challenges and engages the physical, mental and emotional resources of each camper. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to drowning, head/brain injury, and cervical spine injury. Understandably, not all hazards and dangers can be foreseen. The very nature of swimming is hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, horseplay, diving or cannon balling into shallow water and striking the bottom or side of the pool, poor supervision or instruction, lack of conditioning, becoming disoriented, striking other swimmers, defective or inadequate equipment, striking one's head on the bottom when using a diving block, slipping or falling on the deck or within the locker facility, chemical exposure and all

other circumstances inherent to the sport of swimming. In this regard, it must be recognized that it is impossible for the Wood Dale Park District to guarantee absolute safety.

- *Waiver and Release of all Claims and Assumption of Risk* – Please read this form carefully and be aware that in signing up and participating in swim lessons, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program/activity.
  - I recognize and acknowledge that there are certain risks of physical injury associated with participating in this program/activity and I voluntarily agree to assume the full risk of any injuries, damages or loss, regardless of severity, that I or my child/ward may sustain as a result of such participation.
  - Notwithstanding any consultation or instruction on exercise programs which may be provided by the Wood Dale Park District, it is hereby understood that the selection of exercise program, methods and types of equipment shall be me or my child/ward’s entire responsibility, and that the Wood Dale Park District, including its officials, employees, agents and volunteers (hereinafter collectively “District”) shall not be liable for any claims, demands, injuries, damages, or loss to person or property arising out of or in connection with the use of the services and facilities contemplated by this agreement.
  - I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result in participating in the swim lessons against the Wood Dale Park District and its officers, agents, servants, and employees.
  - I do hereby fully release and forever discharge the District from any and all claims for injuries, damages or loss that I or my minor child/ward may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this program/activity.
